**Subject: Display of Provisional Answer Keys and Question Paper with Recorded Responses for Answer Key Challenge of Banaras Hindu University (BHU) Entrance Test – 2021**

The **National Testing Agency (NTA)** has conducted the Banaras Hindu University (BHU) Entrance Test - 2021 for Academic Session **2021-22** for **Undergraduate (UET)** and **Postgraduate (PET)** Programmes on **28 to 30 September and 01, 03, 04, 06 & 09 October 2021** in Computer Based Test (CBT)/ Hybrid (tablets)/ OMR Based mode.

The **Provisional Answer Keys** along with the **Question Paper and Recorded Responses of candidates for Undergraduate (UET) and Postgraduate (PET) Programmes** have been uploaded on the website <https://bhuet.nta.nic.in> for candidates to challenge.

The candidates, who do not agree with the answer key of any question, may challenge the same by paying a fee of **₹ 200/- (Rupees Two Hundred only)**, per challenged question, as a non-refundable processing fee. This facility is available from **03 November 2021 to 05 November 2021 (07:00 pm)**.

The payment of the processing fee may be made through, **Debit card/Credit Card/Net Banking/Paytm/UPI** upto **05 November 2021 (until 11:50 pm)**. No challenge will be entertained **without receipt of the processing fee**. The Challenges **will not be accepted through any other medium** i.e. fax, email or hard copy.

Challenges made by the candidates will be **verified by the panel of subject experts**. If **found correct, the answer key will be revised accordingly**. Based on the revised Final Answer Key, the result will be prepared and declared. **No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge**. The key finalized by the Experts after the challenge will be final. **No challenge will be accepted after 05 November 2021 (07:00 pm)**.

Candidates are advised to make a note of the above and act accordingly.

### Procedure for Challenge of Answer Key

1. Please go to website <https://bhuet.nta.nic.in>.
2. Click '**Answer Key Challenge for BHU Entrance Test – 2021**'.
3. Login with your **Application Number and Password or Date of Birth** and enter Security Pin as displayed and submit.
4. To view the **Question Paper/Recorded Responses**, click '**View Question Paper**'.
5. For OMR Based exam, click '**View OMR**'.
6. For Answer Keys, click '**View/Challenge Answer Key**'.
7. To challenge OMR, click '**click to View & Challenge OMR**'. Select the Test Paper, you will see all questions are in sequential order. The '**Recorded Response as per OMR Sheet**' column is next to the question.
8. To challenge Answer Keys, you will see the **Question IDs are in sequential order**.
9. The ID next to the question under the column '**Correct Option**' stands for the **correct Answer Key** to be used by NTA.
10. If you wish to challenge this option, you may use **any one or more of the Option IDs given in the next four columns** by clicking the check box
11. After clicking your desired option, scroll down, '**Save your Claim**' and move to next screen.
12. You will see a **display of all the Option IDs** you have challenged.
13. You may want to upload supporting documents in which you can select '**Choose File**' and upload (all documents to be put in a single pdf file).
14. Click on '**Save your Claim and Pay Fee Finally**'.
15. Select Mode of Payment and Pay a non-refundable processing fee @ **₹ 200/- for each question challenged**.
16. Make payment through Debit/Credit Card/Net Banking/Paytm.
