Procedure for Challenge of Answer Key

1. Please go to website: <https://iift.nta.nic.in>
2. Click on '**Challenge(s) regarding Answer Key**'
3. Login with your **Application Number** and **Date of Birth** and enter **Security Pin** as displayed and Submit.
4. Click to '**Challenge Answer Key**' button.
5. You will see **110 Questions IDs**. They are in sequential order.
6. The ID next to the question under the column '**Correct Option (s)**' stands for the correct Answer Key to be used by NTA.
7. If you wish to challenge this option, you may use anyone or more of the Option IDs given under option(s) ID claimed by clicking the check box .
8. After clicking your desired option, scroll down, '**Save your Claim(s)**' and move to next screen.
9. You will see a display of all the **Option IDs** you have challenged.
10. You may want to upload supporting documents, you can select '**Choose File**' and upload (**all documents to be put in a single pdf file**).
11. Click on '**Save your Claim and pay fee**'.
12. You will find a screen displaying your challenges.
13. Kindly pay the processing fee by clicking on '**Pay Fee**'.
14. Select Mode of Payment and Pay your processing fee @ **Rs.1, 000/-** for each question challenged. Make payment through Debit/Credit Card/Net Banking.
15. In case your challenge is found correct, your processing fee will be refunded in the same account.
