1.	Authentication of Mobile Number and e-mail Address	When a Candidate registers, he/she will have to enter the OTP received at their registered Mobile Number. Email verification is not mandatory.
2.	Correction Facility	Correction facility will be given as per schedule mentioned in Information Bulletin.
3.	Choice of Cities	The Choice of exam cities will be displayed to the candidates as filled in the Online Application Form.
4.	Parents / Guardian Income details	Family Annual Income (inclusive of Father's and Mother's annual income). This is a mandatory field.
5. What is SHRESHTA (NETS) – 2024?	<p>The government has approved a new scheme named SHTESHTA (Residential Education for Students in High School in Targeted Areas) for the purpose of providing seats for the meritorious SC boys and girls in the best private residential schools in the country. Every year, it is expected that about (3000) students would be selected for admission in Class 9 and Class 11 under the scheme.</p> <p>The objective of the Scheme for Residential Education for Students in High Schools in Targeted Areas (SHRESHTA) is as follows:</p> <ul style="list-style-type: none"> • To enhance the reach of the development initiative of the government. • To fill the gap in service-deprived Scheduled Castes (SCs) dominant areas in the sector of education by collaborating with voluntary organizations. • To provide an environment for socio-economic upliftment and overall development of the Scheduled Castes (SCs). • To provide access to high-quality education to bright Scheduled Caste (SC) students so that they can explore future opportunities.
9.	What is the responsibility of NTA for SHRESHTA (NETS) – 2024?	To conduct the Entrance Test (SHRESHTA (NETS)-2024) for admission to Class 9 and 11 only for SC candidates.
10.	When will the Online Application form for SHRESHTA (NETS)-2024 be available?	The Online Application Form for SHRESHTA (NETS)-2024 is available between 12.03.2024 to 04.04.2024 (up to 05:00 P.M.) on the website https://exams.nta.ac.in/SHRESHTA/ , http://shreshta.ntaonline.in/ .
11.	When will SHRESHTA (NETS) – 2024 Examination be conducted?	The date of examination is 24 May 2024.
12.	Whether the examination will be offline or online?	SHRESHTA (NETS) – 2024 Examination will be held in pen and paper mode (Offline) in OMR sheet.
13.	How to fill up the ‘Online’ Application Form for SHRESHTA (NETS) – 2024? 14.	What would be the language of Question Paper?	Bilingual (English and Hindi).
15.	What should I do, if ‘continuous timeout’ or ‘file not found error’ occurs while filling the online Application Form of SHRESHTA (NETS) – 2024?	Use an updated version of Mozilla Firefox/Internet Explorer and a good internet connection while filling out the Application Form. In case of Continuous-time out clear cookies and history of the browser and fill in off-peak hours.
16.	Are Candidates required to send / submit any document(s) including Confirmation Page to NTA through Post/ Fax/ By Hand?	Candidates are not required to send/submit any document(s) including Confirmation Page to NTA through Post/Fax/WhatsApp/Email/by Hand.
17.	Is it mandatory to upload SC Category Certificate?	Yes, Uploading of SC Category Certificate is mandatory. In case the SC Certificate is not available at the time of submission of Online Application, an Undertaking to the effect that the candidate will produce the SC Certificate at the time Examination.
18.	Will NTA reserve its discretion to fix the center in a city which is given in Appendix-I?	As far as possible, the Exam Centres are allotted as per the choice of cities of the candidates made in their online Application form. Efforts are made to allot the Centre as per their choice (s) and within city jurisdiction. However, due to administrative/logistic reasons, a different city may be allotted.
19.	Can a centre be allotted by the NTA manually?	No.
20.	In case, the Candidate has uploaded a Blue Signature instead of a Black Signature in the application form of SHRESHTA-2024. Is it okay?	Yes, you can upload signature either in black or blue.

23.	Can anyone cancel the application submitted for SHRESHTA (NETS) – 2024?	Online Application forms once submitted successfully cannot be cancelled/ withdrawn.
24.	Can anyone submit the multiple Application forms with the same mobile no. and Email ID?	From one mobile number two applications can be submitted.

27.	If one does not get Admit Card, whom should be contacted?	The Candidates may please note that Admit Cards will not be sent by post. There will be no arrangement for the safekeeping of any material at the Centre. Neither NTA nor the Centre will be responsible for any loss, delay, etc.
29.	Will any candidate be able to leave early if he/she finishes the test before the allocated test time?	No, the candidate will not be allowed to leave the examination hall/room before the test concludes.

This scheme is only for those candidates who have passed or are appearing in session 2023-2024. For more details refer to the Information Bulletin.																								
34.	What are the age limit/relaxation criteria for the candidates appearing in SHRESHTA (NETS) – 2024?	For Class VIII – Born between 1 st April 2008 – 31 st March 2012 For Class X – Born between 1 st April 2006 – 31 st March 2010.
