APPLICATIONS FOR ADMISSION TO THE MBA (IB) PROGRAMME 2023-25 OF THE INDIAN INSTITUTE OF FOREIGN TRADE-(IIFT-IB) FROM FOREIGN NATIONALS AND NON RESIDENT INDIANS (NRIS)

The National Testing Agency (NTA) has been established by Ministry of Education, Govt. Of India, as an independent/autonomous, self-reliant and self-sustained premier testing organization.

The Indian Institute of Foreign Trade (IIFT) was established in 1963 as an autonomous body under the Ministry of Commerce & Industry to contribute in the skill building for the external trade sector of India.

It has campuses in New Delhi, Kolkata and Kakinada (Andhra Pradesh)

MBA (International Business), programme of IIFT is a six-trimester general management programme with a focus on International Business.

Seats are reserved for Foreign Nationals & NRIs and their admission would be considered on the basis of GMAT score and Interview. Short listed candidates would be required to undergo a Personal Interview at IIFT campus or online interview.
