### NTA Declares NCHM JEE -2019 Result

The Ministry of Human Resource Development (MHRD), Department of Higher Education Government of India (GOI) has established National Testing Agency (NTA) as an independent, autonomous and self-sustained premier testing organization under Society Registration Act 1860 for conducting efficient, transparent and international standards tests in order to assess the competency of candidates for admissions to premier higher education institutions.

The NTA has been entrusted with the responsibility of conducting National Council for Hotel Management Joint Entrance Examination (NCHM JEE-2019) from 2019 onwards for admission to the B.Sc. Course in Hospitality and Hotel Administration (B.Sc.HHA) across the Country.

The National Testing Agency (NTA) has conducted the NCHM JEE-2019 Examination on 27th April 2019 in one shift, from (09:30a.m.-12:30p.m.) during which, a total number of 30,722 Candidates were registered at 100 Centres in 49 Cities of 27 States/UTs. 498 Candidates are registered for the examination at 3 Centres in 3 cities in North Eastern States. 187 Candidates at 2 Centres in 2 Cities in Jammu & Kashmir.

Free Practice Sessions were also conducted through a network of more than 4200 Test Practice Centers (TPCs) to benefit the students of rural areas. The Mock Test was also available online. About 1.61 crore Candidates benefited from Mock Tests using online/offline facility from 8th Sept 2018 till 5th April 2019.

The Examination was conducted without any glitch in 100 centers in 49 Cities in India and was **monitored** in the following ways:-

A Control Room was opened to monitor and facilitate the smooth conduct of the Examination on the ground. 20 State Coordinators, 44 City Coordinators were positioned.

- A third party audit of all Examination Centers was Carried Out.
- In order to prevent any cheating using mobile networks, Jammers were installed in all the centers. A total of about 5249 Jammers were put in place.

Candidates were given opportunity to see their responses to the question papers and to Challenge the answer keys during 03-05 May, 2019.

- Candidate's particulars including Category and Person with Disability (PWD) have been indicated as mentioned by the candidate in the online application form.
