The exams were held in the Computer Based Test (CBT) mode. The test was of objective type, comprising Multiple Choice Questions (MCQs).

A separate exam was held for COVID-19 candidates on 12th October 2020 in 7 disciplines.

The exams were held in 98 disciplines (5 in UG, 20 in PG and 73 in JRF/SRF) for admission to the above-mentioned programmes as per details given below.
