The Candidates are allowed to make corrections latest by **09 January 2022 (upto 11:50 pm)**. Thereafter, no correction in particulars, whatever, will be entertained by NTA under any circumstances. **The additional fee (if applicable) shall be paid by the candidate concerned through Credit/Debit Card/Net Banking/UPI or Paytm wallet generated during the online correction.** The correction facility will be available on the official website <https://csirnet.nta.nic.in> as per the schedule given below:
