Performance Rating of Applicants through Global Aptitude Test for Indian Institutes (PRAGATII) -2022
(Previously called Indian Scholastic Assessment(Ind-SAT))

The Study In India (SII) programme is a flagship project of the Ministry of Education (MoE), Government of India which seeks to promote India as a prime education hub for international students by inviting them to pursue their higher education in the country.

The Programme envisages providing scholarships to foreign students who want to study in India. Selection of candidates for award of scholarships is through an entrance exam called Performance Rating of Applicants through Global Aptitude Test for Indian Institutes (PRAGATII).

It was formerly known as the Indian Scholastic Assessment (Ind-SAT). It is a standardized online exam for students seeking scholarships under the Study in India programme.

This exam is conducted to evaluate the capability and diligence of students applying to pursue higher education in India, at Undergraduate/Post Graduate level. The scores obtained by the candidates in the PRAGATII exam serve as a criterion to shortlist the meritorious students for the allocation of Study in India Scholarships.

National Testing Agency (NTA) is a premier, specialist, autonomous and self-sustained testing organization, under the Ministry of Education, Govt of India. It conducts entrance examinations for admission to /fellowship in higher educational institutions, in India.

National Testing Agency (NTA) has been entrusted with the responsibility of conducting the PRAGATII Examination for UG & PG Candidates for 2022.

Brief details of the exam are given below:

Date of the test	31 July 2022(Sunday)
Duration	90 minutes
Timings	Exam will be held in 3 sessions. Exact timing of each candidate will depend on his location and will be indicated on his/her Admit Card
Pattern of the test	Objective Type Test comprising 90 Multiple Choice Questions
Mode of conducting the exam	Online (Internet Based)-Remote Proctored. Candidates are not required to visit any exam centre for appearing in the exam. They can take the exam from
