Mains Paper-I	100	02 hours	General Knowledge and Current Affairs (20 Marks), General Aptitude (20 Marks), Elementary mathematics (20 Marks), English language proficiency (20 Marks), and knowledge related to intellectual property rights (IPRs) (20 Marks)
Mains Paper-II	300	03 hours	Technical/scientific discipline of the vacancy applied for.
