Subject: NTA Declares the Result / NTA Scores of National Common Entrance Test (NCET) 2024 – reg.

The National Testing Agency (NTA) has been entrusted with the responsibility of conducting the **National Common Entrance Test (NCET) for admission to the 04-Year Integrated Teacher Education Programme (ITEP) in selected Central/State Universities/Institutions including IITs, NITs, RIEs, and Government Colleges for the Academic Session 2024-25.**

The NTA conducted the **National Common Entrance Test (NCET) 2024 for admission to 4-Year Integrated Teacher Education Programme (ITEP) in selected Central/State Universities/Institutions including IITs, NITs, RIEs, and Government Colleges for Academic Session 2024-25 on 10 July 2024 / 19 आषाढ़ 1946 (Wednesday) 178 Cities and 13 mediums across the country in Computer Based Test (CBT) mode from 02:00 P.M. to 05:00 P.M.**

A total of **64 Central/State Universities/Institutions including IITs, NITs, RIEs, and Government Colleges** participated in the NCET 2024 for the Academic Session 2024-25.

The **NCET 2024** provided access and flexibility in the following ways:

- In total, **66 subjects (38 languages, 27 Domain-Specific Subjects, and One General Test)** were offered for the candidates in the NCET 2024. Three new subjects **Garo (220), Khasi (221), and Pali (222)** were added for the first time. A Candidate had to choose 07 Subjects including two languages (Indian and Foreign), three domain subjects, a General Test, and Teaching Aptitude. However, the candidates were registered in 58 subjects only and appeared in 56 subjects.
- The medium of the Question Paper was in 13 languages (**English, Hindi along with regional languages i.e. Assamese, Bengali, Gujarati, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu**) so that the candidate from different regions could attempt in their own medium and feel comfortable to write and understand the pattern/method of the examination.
- An overall choice in all subjects was given to all candidates in order to cater to the decision of different Boards across the country regarding the reduction of the syllabus. In languages and Teaching Aptitude, candidates had to attempt any 20 questions out of 23, and for domain-specific subjects and the General Test, 25 questions out of 28 questions were to be attempted.
- The candidates, who were not able to select Language 2 as they had not studied the other language in their Class 12, so they were unable to apply for the same. In order to support these

- 151 City Coordinators and approximately 537 Observers were positioned in different centres across the country.
- Live CCTV Surveillance was planned in all examination centres to curb malpractices in the examination. The NTA also made arrangements for live viewing of remote locations of all examination centres from the Control Room located in the NTA premises of New Delhi. Recording of CCTV Systems was also done.
- The examination centres were also monitored using AI-based Video Analytics and Virtual Observers.
- In order to stop cheating using mobile networks, Jammers were installed in all the Centres.

Candidates were given an opportunity to see their recorded responses to the Question Papers and to challenge the Answer Keys from **30 July to 31 July 2024** through the official website of the NCET 2024. Challenges received online were placed before the concerned Subject Experts for verification. A total of 202 challenges with 105 unique counts were received against the provisional answer keys. Based on their feedback, the Final Answer Keys were prepared and those were used to prepare the result the same is being declared today i.e. **09 August 2024 /18 श्रावण 1946** on

For admission in Central/State Universities/Institutions which also include IITs, NITs, and RIEs through NCET 2024, the existing policies regarding quota, category, relaxation, reservations, qualification, subject combinations, preferences, etc. of the respective University / Institution / Government College shall be applicable.

As the eligibility criteria for admission may be unique for every University/Institution, the candidates are advised to visit the University/Institution website to which they are applying for their respective programs.

The role of NTA is confined to the registration of candidates, the conduct of the test, hosting answer keys, inviting challenges, finalizing answer keys, preparing and declaring results, hosting Scorecards, and handing over the score data to the NCTE for further sharing with all participating **Universities/ Institutions/ Government Colleges.**
