- The Admit Card is issued **provisionally to the candidates**, subject to fulfillment of the eligibility condition.
- **Kindly note that for each post the Roll Number and Admit Card will be different.** Therefore, candidates who have applied for more than one post, **are required to download the Admit Card separately for each post.**
- Admit Card will **not be sent by post.**
- Issue of Admit Card, however, **will not necessarily mean acceptance of eligibility** which shall be further **scrutinized at subsequent stages** of the recruitment process.
- Candidates are advised to preserve a copy of their Admit Card and keep it in good condition for further reference.
