If the challenge(s) made by the candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly. Based on the revised Final Answer Keys, the result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. The Keys finalized by the Experts after the settlement of the challenge will be final.

## Procedure for Challenge of Answer Key

- 1) Please go to the website https://exams.nta.ac.in/CMAT/
- 2) Login with your Application Number, Password or Login with Application Number and Date of Birth and enter Security Pin as displayed and click on Login Button.
- 3) Click 'View/Challenge Answer Key' button.
- 4) The Option(s) next to the Question ID under the column 'Correct Option(s)' stands for the most appropriate Answer Key to be used by NTA.
- 5) If you wish to challenge this option, you may use any one or more of the Option given in the next five columns by clicking the check box
- 6) You may want to upload supporting documents in which you can select 'Choose File' and upload (all documents to be put in a single pdf file).
- 7) After clicking on your desired Option(s) ID for Challenge scroll down and click on 'Submit and Review Claims' and move to next screen. You must ensure to select all the required options(s) before moving further.
- 8) You will see a display of all the Question ID and Option(s) you have challenged. You may still modify your selection by clicking on 'Modify Claim'. Once you have selected all the Option(s) ID for Challenge you can click on 'Save Claim and Pay Fee'.
- 9) Click on 'Save Claim and Pay Fee' to select payment options. No modification will be allowed after payment.
- 10) Select Mode of Payment and Pay a non-refundable processing fee @ ₹ 200/- for each question challenged. Make payment through Debit Card/Credit Card/Net Banking/UPI.
