**Subject: Correction in the particulars of the online Application Form of Joint Integrated Programme in Management Admission Test (JIPMAT) –2026-reg.**

National Testing Agency will be conducting JIPMAT- 2026 on 07 June 2026 from 03:00 PM to 5:30 PM (Indian Standard Time). This examination will be conducted in Computer Based Test (CBT) mode at various exam centers in India and abroad.

2. As per the information published in Information Bulletin and Public Notice dated 16 April 2026 and 10.05.2026, it has been decided to provide an opportunity to candidate to make corrections in the particulars of their respective Application Form of JIPMAT-2026, as per the following schedule:

JIPMAT -2026	15-17 May 2026 (up to 11:50 P.M.)	As per Annexure- 1

*Note- Final correction shall be applicable only after payment of an additional fee, if required. In case of change in Category, or Pwd/PwBD, if there is an impact on the fee amount then the Candidate will be charged an excess fee as applicable. Excess payment made will not be refunded, if any.*

3. All the registered candidates for the said Examination are advised to visit the website and verify their particulars. They are further advised to make corrections in their particulars, in their respective Online Application Form, if required, as per Annexure –I.

4. The candidates are allowed to make the corrections, latest by 17 May 2026 (Up to 11:50 P.M.). Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through Credit/Debit Card/Net Banking or UPI.

5. Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are informed to do the correction carefully, as no further chance for correction will be given to the candidates.

3.	Candidate shall be allowed to <b>change all the fields:</b>	i. Class 10/ equivalent details ii. Class 12/ equivalent details
4.	Candidates shall be allowed to change <b>examination cities based on their Permanent and Present address (it is once again clarified that NTA is not bound to follow the choices given by the candidates):</b>	i. Examination city selection
5.	Candidates shall be allowed to <b>change all the fields:</b>	i. Date of Birth ii. Gender iii. Category iv. Sub-category/PwD/PwBD (if not verified by UDID) v. Signature
7.	Candidates shall be allowed to change identity details ( <b>only for candidates who registered with identity other than Aadhaar</b> ):	Aadhaar details
<b>Note:</b> i. If there is an impact on the fee, then the additional fee will be charged as applicable. However, in any case the fee will not be reimbursed. ii. Correction in these fields will be applicable only after payment of an additional fee, if any. iii. The only one-time correction will be allowed to the candidate i.e. once the corrections are done and submitted, the form shall be frozen.
