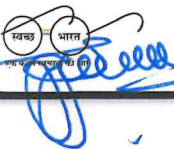
Subject: Correction in particulars of the Online Application Form for UGC-NET June 2026.

- The NTA has been entrusted by the University Grants Commission (UGC) with the task of conducting UGC-NET, which is a test to determine the eligibility of Indian nationals for
(i) 'award of Junior Research Fellowship and appointment as Assistant Professor',
(ii) 'appointment as Assistant Professor and admission to Ph.D.'
(iii) 'admission to Ph.D. only' in Indian universities and colleges.
- As per the Information Bulletin and earlier Public Notice, it has been decided to provide an opportunity to make corrections in the particulars of the Online Application Form of UGC-NET June 2026 examination, as per the schedule given below:

- All registered candidates are advised to visit the official website <https://ugcnet.nta.nic.in>, and verify their particulars in their respective Online Application Forms. If required, they may make corrections in the permitted fields only within the above period.
- This facility is extended only once to avoid any hardship to the candidates. Therefore, candidates are advised to make corrections carefully, as no further opportunity for correction will be provided. **No corrections will be accepted after 28 May 2026 (11:50 P.M.) under any circumstances.**
- Only one-time correction will be allowed to the candidate i.e. once the corrections are done and submitted, the form shall be frozen.
- The additional fee (if applicable) shall be paid by the candidate concerned through Credit/Debit Card, Net Banking, or UPI only.**
